

The Martin ELP CL is an ellipsoidal/profile lighting fixture with a 260W red, green, blue, amber & lime LED engine that produces a sharp gobo projection with a flat field.

The Martin ELP WW is an ellipsoidal/profile lighting fixture with a 260W warm white LED engine that produces a sharp gobo projection with a flat field.

The only difference between them are LED types.
